# Part 1 - Introduction

The CRO is a Government organisation under the remit of the Department of Business, Enterprise and Innovation and is the central repository of public statutory company law related information on Irish companies. Its main functions are:

- Incorporation of companies
- Registration of company post-incorporation documentation
- Enforcement, prosecution and striking companies off the register of companies
- Registration of business names/changes in business name particulars
- Provision of information to the public

You can register a Company, Business Name (Trading Name), Foreign Company (External Company) or Limited Partnership with the CRO.

The Companies Registration Office (CRO) Mission Statement is:


to oversee the highest possible rate and quality of annual return filing on the part of companies in accordance with the relevant statutory provisions and to ensure that information on companies published in turn by the CRO is timely and accurately reflects the information provided by those companies.



# PART 2 - Overview of 2019

232,949 Irish companies were in existence on the register at the end of the year, resulting in over 509,713 submissions being filed with the CRO during 2019.


The number of new companies has exceeded the numbers being removed and a steady increase in the size of the register is continuing following a plateau during the economic depression 2008-2014.



# 81% of all documents were filed electronically. At the end of the year, 95% of companies were up-to-date in terms of filing of annual returns.

### Present Make-up of the Register:

Private limited by shares companies make up 89% of all companies on the register. The number of public limited companies continues to fall and there are now a little over 1,000 plc's on the register.



Mandatory electronic filing was introduced in 2017 in relation to the annual return form. The annual return document is responsible for 45% of all documents received. By filing the B1 online there is a saving of €4.5m. Mandatory electronic filing also applies to filing of the forms B2/B10 and B73. There was a saving to the public of €1.6m in relation to these forms in 2019.

The development of electronic filing has helped in the reduction of backlog of documents to be registered. 361,279 documents stood in the 2009 backlog. This was reduced to 269,490 in 2014 and by the end of 2019 the number of unregistered documents against live companies stood at 48,345. By filing online there is a reduced cost or in many cases the filing can be made free of charge.

### Applications to the High Court/District Court for an Order Extending Time to File

Section 343(5) of the Companies Act 2014 states that a company which is late in filing its annual return can make an application to the Court (High Court or the District Court for the district in which the company's registered office is situated) for an order extending the time to file its annual return for that year. It should be noted that only one application can be made to the court in respect of any one financial year and only "live" companies may make an application to the courts under this section – it is not a process available to dissolved companies.

Once an order is granted by the Court and complied with by the company, the annual return will be treated as being on-time and the company will not be required to pay late filing fees or suffer loss of audit exemption. In 2019, CRO received 687 notices of applications from companies to the District Court and 3 notices of application to the High Court.

The CRO issued a total of 654 Letters of Acknowledgement/No Objection/Objection and processed 586 Orders granted by the District Court/High Court. Twenty-six applications were refused by the Courts and 52 applications were withdrawn.

### Legal Developments Companies (Amendment) Act 2019

This Act amends sections 343 of the Companies Act 2014 but has not yet been commenced. It is planned for changes to be made to allow companies to complete the process of filing their annual return online without the need for the signature page to be supplied to the Office physically. Instead the signature page will be uploaded together with the financial statements.

However, it is not possible to do this using the current system employed by the CRO. Only with the redevelopment of computer systems, currently expected in late 2020, will the Act be commenced and the submission requirement amended from 28 days to 56 days.

### S.I. 597 of 2019

The European Union (Qualifying Partnerships: Accounting and Auditing) Regulations 2019 updated requirements for partnerships and limited partnerships. The regulations applied Part 6 Companies Act 2014 (annual return requirements) to limited partnerships.

The regulations also applied Part 26 of the Companies Act 2014 to qualifying partnerships. Part 26 obliges large companies, large groups and "public interest entities" that are active in the mining and extractive industries or the logging of primary forests to prepare and file annual reports on payments made to governments with the CRO. Partnership reports are required to be filed within 11 months of the financial year end. This financial year refers to any financial year which commences on or after 1st January 2020.

### **Redevelopment of IT resources**

The CRO is undertaking a project to redevelop the CRO databases which house both the register of companies and business names. A full refresh is underway to update the current ageing system.

During 2020, the CRO will migrate the registers to a unified, modern database platform. The process will allow the CRO to meet both national and EU commitments to Digital Governance. It is expected that this project will be completed by Quarter 4 2020. As part of this project the register of limited partnerships was migrated to the new platform in June 2019

### Provision of information to the public

Over 340,000 documents were purchased from the CRO website in 2019 and the website was visited 2.5m times. All statutory information provided by companies to the CRO is available to the public for inspection on payment of a small fee where applicable. Certain vital information, such as company name and registered office address, may be checked free of charge on the CRO website.

### **Information Unit**

There continued to be a high volume of calls received to the Office throughout 2019. Over 60,000 phone-calls were answered as well over 15,400 emails. (Email address Info@cro.ie). A large volume of queries was received in relation to the Registry of Beneficial Ownership (RBO) which the Information Unit could not deal with. It is regretted but the RBO is a separate register. It is planned to open a phoneline for the RBO in 2020.

#### **Customer Complaints and Requests for information**

If a customer is unhappy with the service delivered by the CRO and the issue cannot be resolved with the staff member or section dealing with the matter, a formal complaint can be made to the CRO Information Officer. The complaint will be dealt with in accordance with the CRO's Complaint Procedure. If the complainant is still not satisfied, the complainant has the right of appeal to the Office of the Ombudsman.

5 official complaints were received during 2019, two of which were referred to the Office of the Ombudsman. Neither of the complaints to the Ombudsman were upheld. In addition, the CRO received 1 request under the Freedom of Information Act and 3 GDPR data protection requests

# Part 3 - The Company Lifecycle

### Incorporation of a company

A company is a legal form of business organisation. It is a separate legal entity and, therefore, is distinct from those who run it. There are two basic company types, a private company and a public company. The majority of companies registered in Ireland are private companies and, of those, most are small with only one or two members. The CRO recently made a change to the B1 Form asking companies to state whether they are micro, small, medium or large. The first full year breakdown of the number of Irish companies by size will be available in the 2020 Annual Report.

The Companies Act 2014 generally allows one or more persons to form a private company for any lawful purpose by subscribing to a constitution. A private company may have a maximum of 149 members and there is no limit on the number of members of a public company.

All company types, with the exception of the Private Company Limited by Shares (LTD), must have one secretary and a minimum of two directors. (Single director LTDs must have a separate secretary). Formal qualifications are not required to be a company director. All company directors must be over 18 years of age. All company officers have wide responsibilities in law.



IIn 2019, the number of new companies incorporated was 22,723. This represents an increase of 1.3% over 2018 volumes. The increase in registrations has been large in the last five years and predates the enactment of the Companies Act 2014 and the decision of the United Kingdom to leave the European Union. There is an average of 1,894 new companies registered per month which is the highest number of new company registrations ever in the history of the State.

CRO has committed to the following customer service targets for registration of new companies under the relevant schemes:-

- Fé Phrainn Scheme 10 working days
- A1 Online Scheme 5 working days
- Ordinary Scheme 15 working days

Despite the increase in the number of companies being incorporated, CRO continues to meet its customer service targets within existing resources.

### Registration of company post-incorporation documentation

Changes in the situation of a company's registered office or changes amongst a company's officers or in their particulars must be notified to the CRO on the relevant statutory form. The form must be properly completed and signed by a current officer of the company per the CRO records in accordance with the Companies Act 2014.

As the size of the register has grown, so have the number of filings. There were a record number of 77,471 B10 forms (change in director/secretary information) filed in 2019 which increases the accuracy of the register. There were also 18,386 B2 forms (change of registered office) filed during 2019.

### **Annual Returns**

Every company on the register, whether trading or not, is required to submit an Annual Return every year.

An annual return includes details of the company's directors and secretary, its registered office, and details of its shareholders and share capital. It must be signed by a director and by the company secretary. If the secretary is also a director, he/she may not sign in both capacities. Company financial statements are required to be annexed to a company's annual return in most cases. There were over 228,680 annual returns received in the CRO in 2019.

#### **Re-Registrations**

Under the Companies Act 2014, it is possible to change from any company type to another company type e.g. from limited to unlimited, from private to public or from limited by shares to limited by guarantee or vice versa, subject to the requirements of Part 20 of the Act.

In 2019, a total of 400 companies re-registered, down from the high of 676 in 2016.

### **Mortgages and Charges**

Over 12,406 charges were filed in 2019. Registration of charges has been steadily increasing over the last number of years and the 2019 figure represents an increase of 100% over the 2011 volumes. The number of charges registered has now matched levels that were being registered prior to 2008.

### Liquidations and appointment of Receivers

Up-to-date registers of liquidations, appointment of receivers and examiners were maintained by registering all documents received within agreed business plan timeframes. The number of liquidations has plateaued although the number of creditors' liquidations has decreased.

There is a continuing decrease in the number of companies where receivers were appointed over assets of the company - down from 344 in 2017, 167 in 2018, to 114 in 2019. The register of disqualified and restricted directors was also maintained, while reports of companies in liquidation continued to issue to ODCE on a regular basis.

Liquidators are required to submit form E3 (Account of act and dealings) and form E4 (s681 account and affidavit). Receivers are required to submit form E9 (receivers abstract). The numbers of return submissions by liquidators and receivers rose considerably as a result of an enforcement programme that was begun in 2018. This programme is ongoing and the register of companies in liquidation is becoming more accurate as a result.

#### **ICAVs**

The Register of Irish Collective Asset – Management Vehicles (ICAVs) is maintained by the Central Bank of Ireland. The CRO is required under the legislation to de-register companies who have registered as ICAVs with the Central Bank. A certificate of de-registration of the company is issued, the Register records the de-registration of the company and notice of the removal of the company is published in the CRO Gazette. In 2019, seven companies were de-registered.

#### Enforcement, prosecution and striking companies off the register of companies

A company can be dissolved either through liquidation or strike-off. Strike-off is not always involuntary. A company that ceases to trade and has no outstanding creditors can request the Registrar to strike the company off the register.

In 2019 CRO continued to enforce the Companies Act 2014 against companies in default of their annual return filing obligations by way of involuntary strike-off. To encourage compliance, reminder letters are issued to all companies in relation to Annual Return dates. By end 2019 over 95% of companies were up to date with the filing of annual returns.

#### Strike-Off

The number of companies involuntarily struck off the register in 2019 was 5,068 which represented a significant decrease over strike-off levels in 2018 (33%). This reduction is due to the high level of compliance with the requirement to file annual returns. Any company which is late in filing its return is likely to face either strike-off proceedings or prosecution in the District Court. Voluntary strike-off is a statutory process under the Companies Act 2014. A total of 6,025 companies were struck off voluntarily in 2019, which is an increase of 9.4% over 2018.

### **Restoration to the Register**

A company can be restored to the register following strike-off. Where a company has been struck off the register for a period not exceeding 12 months, an application can be made by the company to the Registrar for restoration. Once the 12 months has elapsed, it is only possible to restore the company via Court Order Restoration. A total of 480 companies were restored to the register, a 17% decrease over the number restored in 2018.

### Prosecutions for failing to file annual returns

A total of 56 cases were prosecuted by the CRO in 2019 for failure to file annual returns in respect of the years 2015, 2016, 2017 and 2018. This figure included 4 cases against company directors. 28 cases were convicted and the probation act was applied to 20 cases. One case was withdrawn and one case was struck out. 6 cases were adjourned to February 2020. Fines ranged from  $\in$ 250 to  $\in$ 3,000 in all convicted cases. Total fines came to  $\notin$ 27,350. In cases where the Probation Act was applied the court ordered that a charitable donation be paid. A total of  $\notin$ 11,450 was ordered to be paid in respect of charitable donations.

### Part 4 - Other Entities Registered by the CRO

### **Business Names**

The Registration of Business Names Act 1963 provides transparency for persons trading under a name other than their own. It is obligatory if any individual or partnership (whether composed of individuals or bodies corporate or any combination of both) or body corporate carries on business under a name other than their own true names. Its purpose is to make public the identities of those individual(s), partnerships or corporate bodies being the legal entity behind the business name. Registration of a business name does not result in the creation of an entity with separate legal personality.

The number of new business names registered by the CRO in 2019 was 20,723, a 2% decrease on 2018 with 21,202 registered. 92.4% of new business name applications were filed electronically in 2019.

A change in any of the particulars of a registered business name (e.g. change of business name or business address) should be notified to the Registrar within one month of the date of the change. In 2019, 2,086 changes were registered. 2,777 forms notifying the Registrar of cessation of business were submitted.

### **Limited Partnerships**

The Limited Partnership Act 1907 facilitates the creation of a partnership in which some members have limited liability for the debts of the firm. Their liability is limited to the extent of the amount of capital contributed by them to the partnership. As with a general partnership, a limited partnership is not a separate legal entity. 305 Limited Partnerships were registered in 2019, a reduction on the number registered in 2017 (676) but still an abnormally high number compared to the long-term trend.

#### Income 2019

CRO received €20.1 million in 2019, which represents an increase of 4.3% on the 2018 figure of €19.27m. There has continued to be a reduction in late filing fees paid. 11,059 companies paid late filing fees meaning that the average late filing fee paid by each of these companies was €570.

The CRO is committed to facilitating and implementing more payments by electronic means, over the traditional methods of cash and cheque payments. Since the introduction of mandatory e-filing of the annual return (Form B1) and the accompanying financial statements in June 2017, filing fees and any late filing fees must be paid for by credit/debit card or by customer account.

The number of cheques received in the CRO reduced from 66,116 in 2017 (value  $\in$ 8.6m) to 18,495 in 2018 (value  $\in$ 2.3m) down to 10,992 in 2019 (value  $\in$ 512k). The CRO continues to review alternative payment methods for customers who have traditionally paid by cheque.

A Customer Account can be topped up by Credit Card or through an Electronic Funds Transfer (EFT) provided that the Customer Account number is given as a reference on the EFT and notification is made by email that such a transfer has occurred.

### **Overview of Energy Usage in 2019**

The CRO is located in Bloom House Gloucester Place Lower, Dublin 1 and O'Brien Road, Carlow.

The CRO shares Bloom House along with meeting rooms, toilets and the reception area with the Registry of Friendly Societies (RFS) and the Competition and Consumer Protection Commission (CCPC) as well as private firms. CRO Carlow is the minor energy user of O'Brien Road (45%) and shares the building with the Register of Beneficial Ownership, and the Workplace Relations Commission while also sharing canteen facilities, toilets and the reception area.

Bloom House has an Building Energy Rating of B3. BER No.: 800191413. Energy Performance Indicator: 77.12kg CO2 /m2 /yr 1. O'Brien Road Carlow has a D1 rating.

### Actions Undertaken in 2019

- Energy Saving related emails to staff reminding everyone to turn off PC monitors, printers etc. each evening.
- Monthly 'No-Lift Days'
- Out of Hours energy Audits
- Air Handling Unit operating hours monitored continuously.
- Heating timers regularly programmed in line with current weather conditions (both locations).

# Part 6 - Coming In 2020

#### **Redevelopment of IT resources**

The CRO has undertaken a project to redevelop the CRO databases which house both the register of companies and business names. A full refresh is required to update the system. It is expected that this project will be completed by Quarter 4 2020. Further enhancements will be developed in 2020 in tandem with the redevelopment of the CRO databases.

#### Brexit

Following a traumatic year in politics, the UK's intention to leave the European Union has undergone reassessment and renewal. The Withdrawal Agreement provides for a transition period during which the UK will continue to operate under EU law. The deal allows for a period ending 31st December 2020 before legislation relevant to the EU no longer applies. This transition period can be extended by agreement of all of the parties.

On the UK leaving the EEA (European Economic Area), a bond will be required for companies which have only UK resident directors under Section 137 Companies Act 2014. The bond would be required from the date that the UK eventually leaves the agreements (EEA/EU). There is an alternative to obtaining a bond - namely a statement from Revenue under section 140 Companies Act 2014 (form B67). External companies from the UK will become subject to filing annual returns with the CRO under the non-EEA country legislation. Section 1304 Companies Act 2014 applies in relation to the submission of any changes in the company's information. Section 1305 applies with regards to the annual returns.



### Restoration of Companies to the Register

Chapter 2 Part 12 of the Companies Act 2014 provides for the restoration of a dissolved company to the Register of companies. A company struck off the register may be restored to the Register by application to the:


- High Court before twenty years have elapsed from the date of dissolution;
- - Circuit Court before twenty years have elapsed from the date of dissolution, where the applicant is a creditor;
- - Registrar of Companies before twelve months have elapsed from the date of dissolution, where the application is made by or on behalf of the company.


