It is a criminal offence pursuant to section 876 of the Companies Act 2014 for a person to knowingly or recklessly deliver a document to the CRO which is false in a material particular.

**note two** This section must be completed by the person who is presenting Form B90 to the CRO. This may be either the applicant or a person on his/her behalf.

**note three** In accordance with section 10(2) of the Migration of Participating Securities Act 2019 the filing of a form shall be accompanied by an affidavit sworn by one or more of the Directors of the participating issuer verifying the statement contained herein. This affidavit will be visible on the company register.
