I nGACH CÁS TÁ IARRATAS DÉANTA AG AN gCUIDEACHTA GO mBAINFÍ DEN CHLÁR Í.

- FÉADFAIDH DUINE AR BITH A SHEACHADADH AR AN gCLÁRAITHEOIR AGÓID I gCOINNE BHAINTE NA CUIDEACHTA DEN CHLÁR AR **AN BHFOIRM H16** (ALT 732(2)(B)(I)).
- NÍ MÓR AGÓID AR BITH A BHEITH BUNAITHE AR AN BHFORAS NÁR COMHLÍONADH CEANN AMHÁIN NÓ NÍOS MÓ DE NA COINNÍOLLACHA ATÁ LEAGTHA SÍOS IN ALT 731 AGUS AR AN BHFORAS SIN AMHÁIN.
- FÉADFAIDH AN CHUIDEACHTA FÉIN AN PRÓISEAS UM BAINTE DEN CHLÁR A CHEALÚ ACH **FOIRM H17** A CHUR ISTEACH FAOI ALT 732(4) LAISTIGH DEN TRÉIMHSE 90 LÁ.

MURA BHFAIGHFEAR AN AGÓID I gCOINNE BHAINTE NA CUIDEACHTA DEN CHLÁR LAISTIGH DE 90 LÁ AGUS MÁ S AGÓID Í A SHEASFAIDH AN CLÁRAITHEOIR LÉI NÓ MURA BHFAIGHFEAR IARRATAS ÓN gCUIDEACHTA AR AN bPRÓISEAS A CHEALÚ, FÉADFAIDH AN CLÁRAITHEOIR NA CUIDEACHTAÍ SEO A BHAINTE DEN LIOSTA AGUS DÉANFAR NA CUIDEACHTAÍ A FHOIRCEANNADH.

IS IAD SEO A LEANAS COINNÍOLLACHA ALT 731 –

- (1) (a) tá na himthosca a bhaineann leis an gcuideachta ina gcineál a thugann cúis réasúnach don Chláraitheoir chun a chreidiúint nár sheol sí gnó riamh nó go bhfuil sí scortha de ghnó a sheoladh;
- (b) tá an chuideachta tar éis, laistigh de 3 mhí roimh dháta an iarratais, trí rún speisialta –
- (i) rún a dhéanamh á iarraidh ar an gCláraitheoir go mbainfí den chlár í ar an bhforas nár sheol sí gnó riamh nó go bhfuil sí scortha de ghnó a sheoladh; agus
 - (ii) rún a dhéanamh gurb amhlaidh, agus í ag feitheamh ar chinneadh maidir lena hiarratas um baint den chlár (nó, más túisce é, cealú an phróisis seo, ar a iarraidh), nach mbeidh an chuideachta ag seoladh aon ghnó nó nach mbeidh aon dliteanas á dtabhú aici;
- (c) tá seachadta ag an gcuideachta ar an gCláraitheoir gach tuairisceán bliantúil a cheanglaítear le halt 343 atá dlite i ndáil leis an gcuideachta amhail ar dháta an iarratais;
- (d) tá seachadta ag an gcuideachta ar an gCláraitheoir deimhniú ar an bhfoirm fhorordaithe (H15) agus é sínithe ag **gach stiúrthóir** á dheimhniú gurb amhlaidh, amhail ar dháta an iarratais –
- (i) nach mó ná €150 suim aon sócmhainní de chuid na cuideachta;
 - (ii) nach mó ná €150 suim aon dliteanas de chuid na cuideachta (lena n-áirítear dliteanas theagmhasacha agus dliteanas ionchasacha); agus
 - (iii) nach bhfuil an chuideachta ina páirtí do dhlíthíocht atá ar bun nó ar feitheamh;
- (e) tá deimhniú i scríbhinn faighte ag an gCláraitheoir ó na Coimisinéirí Ioncaim, dar dáta nach luaithe ná 3 mhí roimh an dáta ar a bhfaighidh an Cláraitheoir an t-iarratas, nach bhfuil agóid á déanamh ag na Coimisinéirí Ioncaim i gcoinne bhainte na cuideachta den chlár; agus
- (f) chuir an chuideachta faoi deara gur foilsíodh fógrán, san fhoirm fhorordaithe, maidir lena hintinn iarratas a dhéanamh ar a bheith bainte den chlár, laistigh de 30 lá roimh dháta an iarratais in 1 nuachtán laethúil amháin ar a laghad a scaiptear sa Stát.

(2) I gcás ina ndéanfaidh cuideachta iarratas faoin alt seo i dtaobh a bainte den chlár laistigh de bhliain amháin tar éis an dáta ar ar athraigh an chuideachta a hainm nó a hoifig chláraithe (nó iad araon), ansin sonrú san fhógra dá dtagraítear i bhfo-alt (1)(f), de réir mar a bheidh –

- (a) an t-ainm a bhí ar an gcuideachta roimhe seo, chomh maith leis an ainm atá ar an gcuideachta faoi láthair; nó
- (b) an seoladh a bhí ag oifig chláraithe na cuideachta roimhe seo, chomh maith leis an seoladh atá aici faoi láthair; nó
- (c) an t-ainm a bhí ar an gcuideachta agus an seoladh a bhí ag a hoifig chláraithe roimhe seo, chomh maith leis an ainm atá ar an gcuideachta faoi láthair agus an seoladh atá ag a hoifig chláraithe faoi láthair.
