## Cuid 1 Réamhrá

Oibríonn an Oifig um Chlárú Cuideachtaí (CRO) faoi choimirce na Roinne Fiontar, Turasóireachta agus Fostaíochta. Is í an stór lárnach í d'eolas a bhaineann le dlí na gcuideachtaí reachtúil poiblí faoi chuideachtaí Éireannacha. Is iad seo a leanas príomhfheidhmeanna na hOifige:

- Corprú cuideachtaí
- Doiciméid iarchorpraithe cuideachta a chlárú
- Acht na gCuideachtaí 2014 a fheidhmiú maidir le hoibleagáidí comhdúcháin na gcuideachtaí
- Ainmneacha gnó/athruithe i sonraí na n-ainmneacha gnó a chlárú
- Eolas a chur ar fáil don phobal

Is é seo a leanas Ráiteas Misin CRO:

*chun maoirseacht a dhéanamh ar an ráta agus ar an gcaighdeán is airde agus is féidir i dtaca le comhdú fáiltas ó thaobh na cuideachtaí de i gcomhréir leis na forálacha reachtúla ábhartha agus chun cinntiú go mbíonn faisnéis faoi chuideachtaí a fhoilsíonn CRO dá réir tráthúil agus cruinn agus go léirítear go cruinn léi an fhaisnéis a sholáthair na cuideachtaí siúd.*

## Cuid 2 Achoimre ar 2024

Ba bhliain ghnóthach eile í 2024 don CRO agus dá pháirtithe leasmhara.

Ba ann do 324,531 cuideachta Éireannach ar an gclár ag deireadh na bliana, agus 566,827 aighneacht comhdaithe le CRO le linn 2024 dá bharr. Is ionann 88.39% de na cuideachtaí uile ar an gclár agus cuideachtaí príobháideacha faoi theorainn scaireanna.

Is mó i bhfad fós líon na gcuideachtaí nua a chorprú ná líon na gcuideachtaí ag fágáil an chláir. B'amhlaidh an cás le roinnt blianta anuas, ach géaraíodh ar an méadú de bharr an choisc leanúnaigh ar chuideachtaí a bhaint go neamhdheonach mar gheall ar mhainneachtain i dtaca le tuairisceáin bhliantúla a chomhdú.


Leanadh leis an ardú ar líon iomlán na n-aighneachtaí atá á gcomhdú le CRO, le breis is 560,000 aighneacht a comhdaíodh in 2024 i gcomparáid le 550,000 aighneacht a comhdaíodh in 2023. Arís le linn 2024, comhdaíodh 95% de na haighneachtaí a comhdaíodh le CRO go leictreonach.

Mar a tugadh faoi deara roimhe seo i dTuarascáil Bhliantúil 2023, tháinig fadhbanna chun cinn i mí na Samhna agus mí na Nollag 2023 i dtaca leis an bpróiseas lena mbaintear cuideachtaí ón gclár go neamhdheonach. Mar thoradh, baineadh roinnt cuideachtaí de Chlár na gCuideachtaí go neamhdheonach ar an 26 Eanáir, 2024, agus ar an 2 Feabhra 2024. I ndiaidh comhairle dlí a fháil, soiléiríodh nach raibh an próiseas lena baineadh na cuideachtaí seo bailí agus tugadh an stádas a bhí acu ar an gClár seo roimhe do na cuideachtaí seo arís. Cuireadh an próiseas lena mbaintear cuideachtaí ón gclár ar fionraí arís go dtí gur réitíodh na fadhbanna seo, agus cuireadh tús leis arís ar bhonn teoranta i dtreo dheireadh 2024 agus baineadh na chéad chuideachtaí den chlár i dtús 2025.


Sheol CRO láithreán idirlín nua ar an 3 Aibreán 2024, a tháinig in ionad an tseanláithreáin a mbeadh comóradh 25 bliain aige dhá lá ina dhiaidh seo. Is leagan nuachóirithe athdheartha é an suíomh nua ina bhfuil béim ann ar an reachtaíocht rochtana atá ar na bacáin a chomhlíonadh. Leis an láithreán idirlín nua tá cuíchóiriú déanta ar an bhfaisnéis atá ar an láithreán, tá an t-ábhar nuashonraithe agus tá an leagan amach caighdeánaithe.

Sheol CRO a Thairseach Sonraí Oscailte i dtreo dheireadh 2024. Rinneadh amhlaidh chun an Treoir maidir le Sonraí Oscailte a chur i bhfeidhm chomh maith le Rialachán Cur Chun Feidhme (AE) 2023/138 níos deireanaí lena tugadh isteach coincheap “na tacair ardluacha sonraí”. Leagadh amach sa rialachán cur chun feidhme téamaí na dtacar ardluacha sonraí, trí shé chatagóir sonraí théamacha a shonrú ar cheann acu siúd tá “cuideachtaí agus úinéireacht cuideachtaí”. Leis an rialachán, leagtar amach cad iad na sonraí cuideachta ba chóir a chur ar fáil agus conas atá na sonraí le cur ar fáil. Tá bunfhaisnéis chuideachta agus ráitis airgeadais sna sonraí atá ar fáil ar Thairseach Sonraí Oscailte CRO. Tá an fhaisnéis ar fáil saor in aisce agus i leagan atá inléite ag meaisín ar [CRO](#).

## Iarratais chuig an Ard-Chúirt/an Chúirt Dúiche le haghaidh Ordú chun an tréimhse Comhdaithe a Fhadú:

Tugtar le fios le hAlt 343(5) d'Acht na gCuideachtaí 2014 gur féidir le cuideachta a bhfuil moill uirthi i dtaca lena tuairisceán bliantúil a chomhdú, iarratas a dhéanamh chuig an gCúirt (an Ard-Chúirt nó an Chúirt Dúiche don dúiche ina bhfuil oifig chláráithe na cuideachta lonnaithe) le haghaidh ordú ag fadú na tréimhse dá tuairisceán bliantúil a chomhdú don bhliain sin. Ba cheart go dtabharfaí faoi deara nach féidir ach aon iarratas amháin a dhéanamh leis an gcúirt maidir le haon bhliain airgeadais ar leith agus nach féidir ach le cuideachtaí “beo” iarratas a dhéanamh leis an gcúirt faoin alt seo – níl fáil ar an bpróiseas ag cuideachtaí scortha.

Chomh luath is atá ordú deonaithe ag an gCúirt, agus é comhlíonta ag an gcuideachta, caithear leis an tuairisceán bliantúil amháin is go raibh sé in am agus ní cheanglófar ar an gcuideachta táillí comhdaithe dhéanaigh a íoc nó ní bheidh sí thíos le cailliúint díolúine ó iniúchadh. In 2024, fuair CRO 1,938 fógra iarratas ó chuideachtaí chuig an gCúirt Dúiche nó an Ard-Chúirt.

D'éisigh CRO 1,858 Litir Admhála/Gan Aon Agóid. Chuir CRO agóidí isteach i dtaca le cúig iarratas. Phróiseáil CRO 1,749 Orduithe a dheonaigh an Chúirt Dúiche/ an Ard-Chúirt. Níor dhiúltaigh na Cúirteanna d'iarratas ar bith. Tarraingíodh 14 iarratas siar. Cuireadh 231 iarratas ar athlá ó 2024 go 2025.

## **Athbheithniú Breithiúnach**

In 2023, rinne dhá chuideachta, Greenay Limited agus Kitchen Innovations Limited, iarratas in dhá Cheantar Cúirte Dúiche éagsúla sa stát (ceantar Chúirt Dúiche Chathair Bhaile Átha Cliath agus ceantar Chúirt Dúiche na Gaillimhe) faoi alt 343(5) chun síneadh ama a fháil chun a dtuaisceáin bhliantúla a chomhdú. Bhí gach comhlacht déanach ag comhdú a dtuaisceán bliantúil ag an tráth ina ndearna siad iarratas ar shíneadh ama chun a dtuaisceáin a chomhdú. Mar thoradh orthu a bheith déanach ag comhdú a dtuaisceáin bhliantúla, bheadh ar gach cuideachta táillí comhdaithe dhéanaigh a íoc agus chaillfidís díolúine iniúchta don dá bhliain díreach i ndiaidh dóibh a bheith déanach ag comhdú a dtuaisceán.

Le hAlt 343(5) d'Acht, 2014, foráiltear, in ainneoin gur féidir leis an gCúirt Dúiche ordú a dhéanamh chun an t-am chun tuairisceáin bhliantúil a chur isteach a shíneadh, nach féidir ach ordú amháin a dhéanamh i leith na tréimhse áirithe lena mbaineann an tuairisceán atá i gceist.

Fuair an dá chuideachta Orduithe ó na Cúirteanna Dúiche i mBaile Átha Cliath agus i nGaillimh faoi seach, rud a thug síneadh ama dóibh chun na tuairisceáin bhliantúla, nár leagadh isteach go fóill, a chomhdú. Mhainnigh an dá chuideachta na tuairisceáin bhliantúla, nár leagadh isteach, a leagan isteach laistigh den am a ceadaíodh leis na hOrduithe a rinneadh sa Chúirt Dúiche. Chuaigh gach cuideachta ar aghaidh chun iarratas a dhéanamh ar am breise, de bhreis agus de bharr ar an am a cuireadh ar fáil dóibh san Ordú Cúirte Dúiche agus a fuair siad. I ngach cás, dheonaigh na Cúirteanna Dúiche i mBaile Átha Cliath agus i nGaillimh am breise do na cuideachtaí chun a dtuaisceáin bhliantúla a chomhdú, de bhreis agus de bharr ar an am a cuireadh ar fáil do na cuideachtaí seo faoi alt 343(5).

Bhí an Chlárallann den tuairim gurb ionann na horduithe breise a rinne na Cúirteanna Dúiche i ngach cás agus dara hordú i leith tuairisceán bliantúil gach cuideachta, agus mar thoradh nach raibh sé de chumhacht ag an gCúirt Dúiche an dara hOrdú a dheonú do gach cuideachta.

Ba é tuairim na Clárlainne nár cuireadh tuairisceáin bhliantúla an dá chuideachta ar fáil de bhun cheanglais Acht na gCuideachtaí, 2014, i leith an dá thréimhse. Ba é tuairim na Clárlainne gur cuireadh na tuairisceáin bhliantúla seo ar fáil de bhun Orduithe Cúirte a rinneadh contrártha le téarma Acht 2014. Ar an gcúis seo, bhí deacracht fhollasach ann do Chlárallann dá dtaispeánfadh an clár gur cuireadh tuairisceáin bhliantúla an dá chomhlacht seo ar fáil de bhun an Achta.

Ar an gcúis seo, thionscain an Chlárallann imeachtaí Athbheithnithe Bhreithiúnaigh san Ard-Chúirt ag iarraidh Orduithe na gCúirteanna Dúiche a chur ar neamhní. Éisteadh an tAthbheithniú Breithiúnach san Ard-Chúirt i mí na Nollag, 2024, agus forchoimeádadh an breithiúnas.<sup>3</sup>

## **Iniúchóirí Neamhchláraithe**

In 2024, ní raibh aon tuairiscí faoi iniúchóirí neamhchláraithe ag iarraidh tuarascála iniúchóirí bréagacha a chomhdú. Bhí 12 cás inar chuir iniúchóirí CRO ar an eolas gur baineadh úsáid as a nUimhir Chlárúcháin Iniúchóirí (UCI) ar mhaithe le tuarascálacha iniúchóirí a chomhdú gan chead. Ní raibh aon chás inar mhaígh iniúchóir gur baineadh úsáid as a s(h)onraí trí dhearmad. Nuair a chuirtear CRO ar an eolas faoi chásanna dá leithéid, d'fhéadfaí go gcuirfí na sonraí ar aghaidh go dtí an tÚdarás um Fhorfheidhmiú Corparáideach (UFC) lena n-iniúchadh.

Tá CRO ag leanúint léi i mbun faireacháin ar na rialuithe lena laghdaítear an riosca go dtarlódh a leithéid de chásanna. Leis an meicníocht atá i bhfeidhm lena gcuirtear an t-iniúchóir ar an eolas gach uair a úsáidtear an uimhir chlárúcháin iniúchóirí, is féidir le hiniúchóirí CRO a chur ar an airdeall nuair a bhaintear mí-úsáid as a n-uimhir chlárúcháin, agus mar thoradh tá laghdú suntasach tagtha ar líon na n-iniúchóirí neamhchláraithe atá ag iarraidh tuarascálacha iniúchóirí a chomhdú. Ó tugadh isteach an Uimhir Chlárúcháin Iniúchóirí in 2012 tá laghdú tagtha ar líon na dtuarascálacha faoi iniúchóirí neamhchláraithe ag iarraidh tuarascálacha iniúchóirí a chomhdú, ó 123 in 2012 go dtí a náid in 2024, agus tá laghdú ó 33 go 12 tagtha ar líon na dtuarascálacha faoi úsáid gan chead a baineadh as Uimhreacha Clárúcháin Iniúchóirí.

### Soláthar faisnéise don phobal

Ceannaíodh breis is 380,000 doiciméad ó láithreán gréasáin CRO in 2024 agus tugadh 1.3m cuairt ar an láithreán gréasáin. Tá fáil ag an bpobal ar an bhfaisnéis reachtúil uile a chuir cuideachtaí ar fáil don CRO le hiniúchadh i ndiaidh dóibh táille bheag a íoc nuair is ábhartha. Is féidir faisnéis bhunriachtanach áirithe, amhail ainm na cuideachta agus seoladh cláraithe na hoifige, a sheiceáil saor in aisce ar an tairseach CORE <https://core.cro.ie>.

### Forbairtí Dlíthiúla

Le hAcht na gCuideachtaí (Rialachas Corparáideach, Forfheidhmiú agus Forálacha Rialála), 2024, feabhsaítear agus leasaítear an creat reachtaíochta a cuireadh ar fáil in Acht na gCuideachtaí, 2014, i réimsí an rialachais, an riaracháin, na dócmhainneachta, an fhorfheidhmithe agus na maoirseachta. Tháinig formhór fhorálacha an Achta i bhfeidhm ar an 3 Nollaig, 2024:

- chun foráil a dhéanamh d'iompar cruinnithe ginearálta cuideachta nó cumainn tionscail agus choigiltis, agus do rannpháirtíocht iontu, trí úsáid a bhaint as teicneolaíocht cumarsáide;
- chun foráil a dhéanamh d'fhorais bhreise lena mbaintear cuideachtaí go neamhdheonach ón gclár;

- chun foráil a dhéanamh do dhífheidhmiú an Achta um Promhadh Ciontóirí, 1907, do chion faoi alt 343 d'Acht, 2014;
- chun foráil a dhéanamh do chion ina gcuirtear cosc nó bac ar oifigeach ón Údarás um Fhorfheidhmiú Corparáideach ina gcuirtear isteach air/uirthi;
- chun leasuithe áirithe a dhéanamh maidir leis an bpróiseas tarrthála do chuideachtaí beaga agus micreachuideachtaí
- chun cur ar chumas an Údaráis Maoirseachta Iniúchta agus Cuntasaíochta na hÉireann treoir eatramhach a eisiúint i gcúinsí áirithe;
- chun cur le liosta na n-údarás inniúil ar féidir leis an Údarás um Fhorfheidhmiú Corparáideach faisnéis, leabhair nó doiciméid a nochtadh dóibh faoi alt 792 d'Acht 2014;
- chun cur ar chumas comhlachtaí sonracha faisnéis a nochtadh don Údarás um Fhorfheidhmiú Corparáideach faoi alt 944Q d'Acht 2014;
- chun cur ar chumas an Údaráis Maoirseachta Iniúchta agus Cuntasaíochta airgead a íocadh isteach sa chúlchiste a úsáid i gcomhréir le halt 919 d'Acht 2014 agus a dualgais á gcomhlíonadh aige faoi alt 934 den Acht sin;
- chun roinnt forálacha ó Acht 2014 agus Acht um Chumainn Tionscail agus Choigiltis, 1893, a aisghairm.

Forálacha a dtabharfar tosach feidhme dóibh in 2025: Is iad na 26 foráil nár tugadh tosach feidhme dóibh ná na cinn óna bhfuil nuashonraithe teicniúla ar chórais TF CRO ag teastáil chun na hathruithe atá beartaithe a éascú. Baineann na forálacha seo le foirmeacha aighneachta do CRO a ordú agus le baint na díolúine iniúchta caillteanais uathoibríoch ó chuideachtaí beaga an chéad uair a mhainníonn siad cuntas bliantúil a chomhdú. Tá sé beartaithe tosach feidhme a thabhairt do na forálacha seo in 2025.

## Cuid 3 Saolré na Cuideachta

### Corprú Cuideachta

Is foirm dhlíthiúil d'eagraíocht ghnó í cuideachta. Is eintiteas dlíthiúil ar leith í agus, mar sin de, ní hionann í agus na daoine atá á reáchtáil. Is ann do dhá chineál cuideachta bunúsacha, cuideachta phríobháideach agus cuideachta phoiblí. Is cuideachtaí príobháideacha iad tromlach na gcuideachtaí atá cláraithe in Éirinn agus, astu siúd, tá a bhformhór beag gan ach ball amháin nó beirt.

Go ginearálta, ligtear le hAcht na gCuideachtaí 2014 do dhuine amháin nó níos mó cuideachta phríobháideach a chur le chéile le haghaidh aon chríche atá dleathach trí chlárú le bunreacht. Is féidir le cuideachta phríobháideach uasmhéid de 149 ball a bheith aici agus níl aon srian ar líon na mball de chuid cuideachta poiblí.


Ní mór do gach cineál cuideachta, seachas Cuideachta Phríobháideach faoi Theorainn Scaireanna (TEO), ar a laghad rúnaí amháin agus beirt stiúrthóirí a bheith acu. Ní mór do TEOanna aon stiúrthóir amháin rúnaí ar leith a bheith acu. Níl aon ghá le cáilíochtaí foirmiúla le bheith mar stiúrthóir cuideachta. Ní mór do gach stiúrthóir cuideachta a bheith os cionn 18 bliana d'aois. Tá freagrachtaí fairsinge faoin dlí ag gach oifigeach cuideachta agus ba cheart go nglacfaidís na céimeanna cuí le cinntiú go bhfuil siad go hiomlán ar an eolas faoina n-oibleagáidí. Tá tuilleadh faisnéise faoi dhualgais na stiúrthóirí agus na rúnaithe ar fáil ag [Dualgas na Stiúrthóirí agus na Rúnaithe - CRO](#).

In 2024, ba é líon na gcuideachtaí nua a corpraíodh ná 23,652. Is ionann é seo agus méadú 5.7% i gcomparáid le 2023 bliain inar corpraíodh 22,384 comhlacht nua. Le linn 2024, ar an meán, cláraíodh 1,971 cuideachta nua in aghaidh na míosa, i gcomparáid le meánmhéid míosúil de 1,865 in 2023. Is é an treocht ghinearálta ó bhí 2016 ann go gcorpraítear 20,000 cuideachta gach bliain le buaic de 25,468 in 2021.

Is ann do dhá scéim corpraithe. Tá gealltanais tugtha ag CRO i dtaca leis na spriocanna seirbhíse custaiméara seo a leanas le haghaidh cuideachtaí a chlárú faoi na scéimeanna ábhartha:-

- Scéim Fé Phráinn - 5 lá oibre
- Gnáthscéim A1 Ar Líne - 10 lá oibre

### Cuideachtaí Seachtracha

Bhí 181 clárúchán cuideachta seachtraí nua in 2024, 37 EEA agus 144 neamh-EEA. Tá sé sin i gcomparáid le 192 clárúchán cuideachta seachtraí in 2023.

Bhí 3,518 cuideachta sheachtrach ar an gClár ag deireadh 2024, méadú ar an líon 3,337 ag deireadh 2023. Bhí 507 brainse cuideachta seachtraí EEA agus 3,011 brainse neamh-EEA ar an gclár ag deireadh 2024.
